Terms & Conditions:

1. Purpose of Sale

This puppy is sold exclusively as a family companion. Breeding is strictly prohibited unless the Buyer obtains prior written approval from the Seller.

2. Health Declaration

The Seller affirms that the puppy is in good health and has received a veterinary examination prior to transfer. Age-appropriate vaccinations and deworming have been administered. A copy of the medical records will be provided to the Buyer.

3. 1 – YEAR Health Guarantee

The Seller offers a 1-year guarantee against life-threatening congenital or genetic conditions. - If such a condition is diagnosed within this period, the Buyer must submit documentation from a licensed veterinarian.

- Once verified, the Seller will:
- Offer a replacement puppy of equal value, or
- Provide a partial or full refund, depending on the circumstances.

4. Veterinary Check Requirement

The Buyer agrees to have the puppy examined by a licensed veterinarian within 72 hours of receipt. Failure to do so will render the health guarantee null and void.

5. Return & Rehoming

If at any time the Buyer is unable to retain ownership of the puppy, they agree to notify the Seller immediately.

- The Seller will assist in rehoming the puppy.
- No refunds will be issued in these circumstances.
- Under no condition shall the puppy be surrendered to a shelter, rescue, or third party without first contacting the Seller.

6. Ownership Transfer

Full ownership of the puppy is transferred to the Buyer only upon receipt of full payment and the signing of this agreement by both parties.

7. Shipping (If Applicable)

The puppy may be shipped via air in a pet-safe crate.

- Shipping Cost: \$300 (payable by the Buyer).
- Shipping arrangements must be confirmed in advance.

8. Legal Jurisdiction

This agreement shall be governed by and construed in accordance with the laws of the state where the Seller is located, without regard to its conflict of laws principles. Any legal disputes shall be handled in the Seller's jurisdiction.
